# Pastoral Perspective



What an amazing year 2010 was for St. Luke's! You will read in the annual reports from the Boards all about how the Lord worked mightily though our congregation this last year to further our mission to "Spread the Good News, Serve those in Need, and Share the Victory of Jesus Christ". As we

give thanks for the vital ministry done through us in 2010 and look forward to what the Lord has in store for us in 2011, I invite you to consider with me the Biblical basis for our congregational mission.

Our full congregational mission statement is: "By the power of the Holy Spirit, we accept God's call to spread the Good News, serve those in need, and share the victory of Jesus Christ throughout the world." We confess right from the get go that we don't have the power to do the Lord's work on our own. We must be empowered by the Holy Spirit if we are going to be effective. Jesus tells His followers just before His ascension that "...you will receive power when the Holy Spirit has come upon you, and you will be my witnesses in Jerusalem and in all Judea and Samaria, and to the end of the earth." (Acts1:8) The Holy Spirit has come upon the Church, the people of God. It is by the power of the Holy Spirit that we accept God's call to participate in the Lord's work.

We focus on three vital actions that we accept as God's call for us. The first is to "Spread

the Good News". On Christmas night the angel told the shepherds, "I bring you good news of a great joy that will be for all the people. For unto you is born this day in the city of David a Savior, who is Christ the Lord." (Luke 2:10, 11) When the shepherds saw the baby, "they made known the saying that had been told them concerning the child." (Luke 2:17) We then, join in a long line of folks who have seen with eyes of faith that the Savior has come in Jesus the Messiah of the world. We accept God's call to spread that Good News, because it is "for all the people". Our worship and music ministries, educational ministries and elements of our evangelism ministries are all about "Spreading the Good News".

The second part of our mission is to "Serve those in need." When Jesus appears at the end of time He will say to those who have seen with the eyes of faith who He really is and so served in love those in need, "Come, you who are blessed by my Father, inherit the kingdom prepared for you from the foundation of the world. For I was hungry and you gave me food, I was thirsty and you gave me drink, I was a stranger and you welcomed me, I was sick and you visited me, I was in prison and you came to me." (Matthew 25:34-36) We know in our hearts that whenever we serve those in need we are actually serving Jesus. He comes to us in many "distressing disguises" to allow us the privilege of serving Him. Our community concerns, much of our evangelism ministries, and a great deal of the ministry of the Women of the ELCA are all about "Serving those in need."

The third part of our mission is to "Share

the Victory of Jesus Christ throughout the world." Paul writes at the end of some wonderful sharing about the resurrection, "The sting of death is sin, and the power of sin is the law. But thanks be to God, who gives us the victory through our Lord Jesus Christ." (1 Corinthians 15:56, 57) The powers of sin and death cannot overcome us because Jesus has won the victory over them. We accept God's call to share this victory because it is for all of "us" throughout the world. Our Property ministries are important not only for our facility needs but the needs of so many groups within the community to share. Our stewardship and finance ministries are all about the victory we take part in as we share the resources God gives us to use. In our youth ministries we are sharing with young people the victorious life in the Lord's love. Our church council and special committees help facilitate our sharing of the victory of Jesus Christ.

We truly have a tremendous mission to take part in as a congregation. I thank you for the great privilege of serving as you pastor in this wonderful work.

Holly Hoppman, representing the Blumhardt Memorial Committee, presented the list of suggested projects and estimated costs to the council for review. The Church Council grouped and prioritized the projects for expending the Blumhardt Memorial funds to present to the congregation for review and approval at a congregational meeting scheduled on February 13th following the second church service. The Property Board announced that their meetings will be held the second Tuesday of each month at 6:00pm. They will host quarterly workdays meeting the second Saturday in February, May, August and November from 8:00am - noon. Property Board projects include replacing the threshold for the Sanctuary West Double Door as soon as the weather permits and work on the Multi-purpose room sponsored by W-FLCA.

2010 Year in Review

Let's take a moment to reflect on the many Educational Opportunities we had in 2010 at St. Luke's. Our children were taught Sunday school by Kirsten Ireton. We hap-

pily welcomed Samantha Basquez as the new preschool teacher for our children age 2 through Kindergarten in October. We continue to have members of the youth group assisting with Sun-

day school. This summer our children continued to learn about Jesus and God's Perfect Love for us. In the fall they held a bake sale which raised \$214.50 for the Agape Boy's Mission in Kenya. They also participated in the choir's Christmas Cantata. Our Sunday school attendance continues to grow and is averaging around 7 children, although some Sundays we have had as many as 13 children in attendance!

In the spring Pastor Confirmed three youth: Elise Mihanovich, Katy Etchison, and Wesley Lester. Currently there are 4 youth in Confirmation class with Pastor Carl: Joshua Bell, Daniel Encinas, Katie Light, and Selena Connell. They meet on the 1st, 3rd, and 5th Sundays and are using some of the Divine Drama materials as the pictures are easy to understand and explain. Each week they take home a graphic to share with there parents.

Our adult Sunday school class continues to be well attended. They finished an in-depth discussion of the Reformation and continued to explore the church history through present day. In the fall Pastor started a new class called, "God For Us". We continue to be blessed by his leadership and knowledge and benefit greatly from these wonderful classes.

Crossways Bible Studies continued in 2010 with about 30 people attending. 2011 will bring the start of the New Testament study after our in-depth study on the Old Testament. We were also blessed to host a seminar led by Dr. Harry Wendt on Palm Sunday weekend. Two seminars and lunch were enjoyed by about 65 people. The seminars included "Road to Coronation" and "An Apostles' Creed for the New Millennium". # ANNUAL REPORT - 2010 PROPERTY BOARD

As outlined in the Church Bylaws, the Property Board is responsible for the "general custodial management of this congregation's property and facilities". These responsibles

Property Board sibilities include the care, maintenance, and improvement of the church buildings and grounds. The Bylaws further clarifies that two related activities are assigned to others. These are management of the (a) church insurance needs and (b) use of the church facilities by others, which are the responsibilities of Finance Board and the Facility

Usage Committee, respectively.

In 2010, the Property Board was able to complete a number needed maintenance and improvement projects, primarily because sufficient funds were available and the willingness of skilled church members. The availability of greater-than-usual funds resulted from of several years of moneys accumulated from the Crab Feed and Fireworks Booth fundraiser efforts. These added funds are essential to the continuing maintenance and improvement of the church facilities, which are nearly 50 years old. Thus, please thank the many Crab Feed/Fireworks Booth workers for their efforts, with a special 'thank you' to Deanna and Larry Dockter. The Board encourages everyone to continue their support for these fundraiser efforts – it is critical.

The Board thanks Al Moser for his efforts in keeping watch over the church facilities <u>at all times</u> and for his assistance in keeping the tired, old sprinkler system working (somewhat).

The more note-worthy maintenance and improvement projects completed by the Property Board in 2010 include the following:

Refurbished a large room (Room 5) in the education building for meetings, Sunday coffee, and other uses by removing existing cabinets and installing new cabinets, a sink, and a hot water heater. (\$500)

Replaced the lawn sprinklers at the south end of the church (about 1/4 of total lawn area). Replacement was necessary, as a pipe broke under a large redwood tree (impossible to repair). The new heads are designed to save water and are vandal resistant. (\$2,800)

With the assistance of Ron Webb and Scott Falwell.

obtained inspection and the "final sign off" by the City for the sanctuary/Schulz Hall furnace/ AC project. (\$1,800 for plans/permit)

Installed new furnace/AC units for the education building and removed the obsolete wall furnaces. The heat/cool supply for each room is controlled by a separate thermostat in each room. (\$20,700)

Installed a new furnace/AC for the kitchen and multi-purpose room. (\$7,200)

Requested three roofing contractors to inspect the church roof and provide recommendations and estimates for suggested repairs. One contractor submitted an estimate to replace the roof (\$287,300, including \$99,000 to remove the existing); a second contractor suggested installing new metal caps over the ridge shingles (\$9,800). The third contractor, who was quite experienced with asbestos roofs, stated that overall the roof was in "good shape" and recommended only general maintenance repairs (reset loose shingles, replace broken shingles, etc.). The Board and Council followed this recommendation, and the work was completed late this fall. (\$1,400)

Installed additional insulation (12 inches in thickness) in the attics of the education building, kitchen, and multi-purpose room. (initial cost \$2,200, rebate to be received \$700)

With the assistance of Pastor Carl, relocated and reconnected the external speakers for the carillon system, which has been disconnected for years.

Conducted three Saturday morning "Work Days," during which, minor chores were accomplished. This work included refurbishing Room 5, removing the swing set, performing minor door and window repairs, trimming a dying park tree, power washing the patio and sidewalks, cleaning the gutters, and general cleaning of the grounds.

The Board is grateful to past Property Board chairperson, Bernie Johansen, for her leadership, which enabled sufficient funds to be accumulated for this year's major projects. Thanks Bernie.

Looking ahead, the Board has obtained quotes and developed estimates for potential, future projects. Requests for funding for these projects have been made to Blumhardt Funds Committee. The Board's priority projects include an ADA compliant restroom, repairs for the parking lot, repair or replace several windows and related framing/trim, complete the lawn sprinkler replacement, and security fences for the AC units.

The Property Board was blessed in 2010. It was excellent year and much was accomplished. The Board appreciated the continuing support received throughout the year. Thank you.

In closing, I thank the Board members – Andy Anderson, Phillip Connell, Eric Linblade, and Helper Jack Fenske – for their dedication and unending hours of hard work.

# 2010 Annual Report



With staff changes, changes to worship, our flourishing music program, a new sound system, and the first annual Luau the Board of Worship & Music had a challenging year

with some great outcomes. The members of the 2010 Board of Worship & Music were Peggy Moser, Karen Linfor and Triss Hoppman.

#### Staff Changes

As the year began our Music Director, Jean Chang, was limited in her ability to play piano and organ, due to physical challenges. Jean contacted several musicians and found Brooke Smith as an accompanist. Brooke and Jean worked together for several weeks, but Jean eventually resigned, at her doctor's insistence.

With Jean's departure the Board talked with Brooke and was delighted when she accepted the Music Director position. Brooke is an excellent pianist, vocalist, and choir director; she does not play organ so, the Board split the position into Music Director and Organist. The Organist is responsible for accompanying the liturgies and other musical elements, in concert with the Music Director, on communion Sundays. The Board spent much of the year making contacts seeking an organist, without success. At the end of December, however, Pastor Carl contacted the former organist from Gloria Dei,

who recommended Jane Fanucci. Jane is an accomplished organist who has played for several Lutheran churches in the area for many years. Jane starts January 16, 2011.

# <u>Changes to Worship</u>

On Easter Sunday we began dimming the sanctuary lights during the prelude to encour-



age silence during prayer time before the service. Over the summer concerns were brought to the Board over the length and repetitive nature of the announcements at the beginning of worship. The Board recommended to Council that the announcements be submitted to Pastor so that he could incorporate them at an appropriate place in the service. An announcement form was made available in the narthex.

Our long-time flower provider, Lindale Florist, closed in mid 2010. We were fortunate to make arrangements with a flower wholesaler at approximately the same cost as Lindale. We have developed a good relationship with this company.

In the fall, Nick and Barbara Manlapig took over responsibility for scheduling readers, prayer leaders and psalm leaders. The participants receive the readings in the mail each month along with instructions.

#### Worship Highlights

The Third Annual Epiphany Service and Breakfast, was held and hosted by the Evangelism Board in January. In February, Lent began with Ash Wednesday and 2010's midweek Lenten services and devotions were based on a series about Jonah. The Bell Choir led the Procession of Palms on Palm Sunday and performed on Easter. The Choir season came to a close at the end of May; special music, featuring several groups and soloists, became a big part of Sunday worship during the summer. Under the direction of Brooke Smith, the choir performed a cantata for Christmas, "The Heart of Christmas". This was the choir's first experience with recorded accompaniment. It was well received by the congregation. Since Brooke is experienced in using recorded accompaniment, we expect to do more of it in the future.

# New Sound System

During the summer Council decided to use reserve funds to update and upgrade the sound system in the sanctuary. New equipment was purchased, including a new sound board mixer, microphones, speakers and a compressor. The

speakers that had been in the sanctuary will be used as monitors for the sound board operator and in the cry room. Installation began towards the end of November and continues into 2011.

#### <u>Luau</u>

To open the 2010-2011 choir season, the choir and Board of Worship & Music hosted "An Evening in Paradise" to raise funds for new music and music binders. A Hawaiian dinner was served and the choir and bell choir performed Hawaiian music. We had many participants in the hula-hoop contest and Aloha shirt contest. It was quite successful; we raised close to \$1100 with ticket sales and the sale of leis and drinks. We look forward to it becoming an annual event. In the future, in order to have more time to learn the music, the luau will be held at the end of the choir season in May rather than in September.
