

## Pastoral Perspective



Waiting is hard work. If we are waiting, it says we don't have something we want or need. Currently, we are waiting to be able to get out of the house and gather with others without fear of giving or receiving a horrible virus. There are two primary qualities that we are encouraged by God to

nurture in our lives as we wait.

The first quality is patience. There is simply no peace without patience because no matter how powerful our urges might be for fruition, things won't be rushed. God tells the prophet Habakkuk and us, "If it seems slow, wait for it; it will surely come; it will not delay." Patience is a fruit of the Spirit that allows the Christian to adapt to the inevitable waiting. It is also a means of bringing the Christian into tune with the gradual unfolding of God's plan and purpose. God is working even through this time to bring blessings. When we have the patience to watch and listen and aren't trying to hasten things ahead of their time, we begin to learn how God is working and are enabled to be a part of that working.

The second quality is vigilance. As we patiently wait, we have to remain alert. Otherwise patience turns into stupor. We must wait, but we must also stay awake to what is developing and how we are



## REVISION OF CONSTITUTION AND BYLAWS

During its 94-year history, our church has functioned under a constitution and bylaws that reflected the theology and policies of the church and the Evangelical Lutheran Church of America (ELCA). These documents support our mission to "spread the Good News, serve those in need, and share the victory of Jesus Christ throughout the world." The current constitution and bylaws were last revised in December 2010. In subsequent years, the ELCA has made a few changes with more significant changes made and approved at the churchwide assembly in August of 2019.

Our Church Council has recognized a need to update the constitution for some time, but waited until the major revisions in 2019 were approved. Thus, in late 2019 a small group, consisting of Bob Behr, Betty Englund, Jack Fenske, and Christina Hisamoto, was formed to review St. Luke's constitution and bylaws and to draft new documents that are consistent with the new Model Constitution developed by the ELCA and synods.

The small group completed its work and presented the draft documents to our Executive Committee and Council for further review and approval. Approval was received on February 18, 2020. Subsequently, the draft documents were forwarded to the Sierra Pacific Synod for assessment by their constitution review committee. The Synod committee concurred with the draft documents and the documents were approved by the Synod Council on May 2, 2020.

The final step is to present the revised constitution and bylaws for approval to the Congregation at a congregational meeting followed by a second meeting to ratify the amendments in accordance with constitution procedures. Unlike the 2010 documents where the constitution and bylaws were two separate documents, the proposed 2020 constitution and bylaws are consolidated in one document.

In accordance with the constitution, the Council has made the combined document available to church members so that members can review the document prior to the congregational meetings held to approve/ratify the updated document. There are three ways in which you can access the documents:

1. Go to the Home Page of the website (slelca.org) and "click" on the respective link below the "Give Online" button. There is one link for the proposed constitution and bylaws document and a separate link for the summary of changes from the 2010 version.

- 2. For those not able to access the website, go to the Church Office where copies are available for review. Before coming to the office, please call (916-421-5039) during regular office hours (9:00 12:00, Monday-Thursday) to ensure it is open.
- 3. Email Bob Behr (bkbehr@comcast.net) and request an electronic copy be emailed to your email address.

The date of the meeting has not been set as we continue to be restricted on gatherings. Once the situation becomes better known, the appropriate arrangements and notifications will be made.

The Church Council requests that all members review the proposed, revised constitution/bylaws through one of the options above and be prepared to vote at the designated time. If you have any questions, contact Bob Behr.
